### **ORDER:**

The Additional Chief Secretary/ Commissioner of Revenue Administration in his letter fourth read above, has stated that,

(i) while bringing the part-time Village Assistants working in Revenue Department as on 01.06.1995 into full time Government Service with effect from 01.06.1995 vide G.O. (Ms) No.625, Revenue Department, dated 06.07.1995, the Government have instructed not to fill up the vacancies arising out of retirement, causality, etc. and to prune their cadre strength on par with number of Revenue villages. Apart from this, general ban on recruitment was in existence from 29.11.2001 to 07.02.2006. On account of this, there was no recruitment in the cadre of Village Assistant from 1995 till 2006. Thereupon, appointments in the cadre of Village Assistants under compassionate grounds and as permitted in G.O.(Ms) No.787, Revenue (Ser-VII) Department, dated 06.12.2006 and G.O. (Ms) No.155, Revenue (Ser-VIII) Department, dated 26.03.2020 was made.

(ii) During the period of COVID – 19, it has been ordered in the Government Order first read above that recruitment against entry level vacant posts including compassionate ground appointment shall continue with the approval of Staff Committee. Subsequently, in the Government order second read above, the Government have issued amendment to para 3(ii) of Government Order first read above that "recruitment against existing entry level vacant posts including on compassionate ground shall continue. In cases where the posts have been vacant for more than three years, approval of Staff Committee shall be obtained for revival of the posts prior to filling them up".

(iii) In order to fill up the vacancies existing in the cadre of Village Assistants on the lines of above said Government Orders, all the Collectors were addressed to furnish the vacancy details, and the Collectors have furnished the report accordingly.

(iv) Based on the reports of the Collectors and after scrutiny, it was found that nearly 5,060 vacancies were in existence as on 30.09.2022. In view of large number of vacancies in existence, all the Collectors were instructed to fill up these vacancies which are vacant for less than three years vide letter third read above.

2. In view of the above, the Additional Chief Secretary/ Commissioner of Revenue Administration has furnished the district-wise details of 2,299 vacancies and requested the Government to get the approval of Staff Committee in respect of 2,299 vacancies in the post of Village Assistants existing for more than three years, as ordered in the Government Order second read above. Further, the Additional Chief Secretary/ Commissioner of Revenue Administration has stated that the vanishing category in respect of Village Assistants does not arise.

3. The Government after careful examination of the proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration, hereby accord permission to fill up the 2,299 vacancies in the post of Village Assistant as annexed to this order, which are vacant for more than three years, as per rules in force with special time scale of pay of Rs.11,100/- - Rs.35,100/-.
